Privett's research lies at the intersection of operations management, nonprofit studies, and global public health, focusing on applying the theories and tools of operations management in philanthropy and civil society. Although global civil society actors, such as funders and NGOs, are intervening in developing countries and emerging markets for operational outcomes (e.g., lower market prices and increased availability of products), the questions remain of who, how, where, when and what operational intervention should be executed for specific outcomes. Privett's multidisciplinary research aims to explore this notion of strategic operational interventions to improve health delivery and markets in developing countries.

### PERFORMANCE MEASUREMENT AND MANAGEMENT (PADM-GP 2170)

FALL 2012-PRESENT

This core course for students specializing in management focuses on the fundamentals of performance measurement and how they are critical from a mission, strategic, funding, transparency and accountability perspective. It covers not only how to select appropriate measures, but also how to implement a performance measurement system and use performance measures to manage an organization.

## OPERATIONS MANAGEMENT (PADM-GP 2170)

SPRING 2013- PRESENT

Designed from scratch, this course provides an introduction to operations management in the context of public, nonprofit, and health sectors. In this course, students develop a lens for processes and systems in a variety of contexts along with an analytical toolbox to examine, understand, and improve these.

## THE INTERSECTION OF OPERATIONS AND POLICY: A MULTIMEDIA LEARNING EXPERIENCE IN THE NEW YORK CITY FAMILY HOMELESS SHELTER SYSTEM (PADM- 2140)

FALL 2014-PRESENT

This original course aims to expose students to policy formation in a highly political environment, operations management of systems shaped by state and local policy, and their intersection, while building a toolbox of specific skills that support analysis and decision making. A unifying Multimedia Interactive Case Study focused on the NYC family homeless shelter system will be the backdrop of this course.
