#### **Prerequisites**

- ECON-UA2 Introduction to Microeconomics, or equivalent
- This course requires a working knowledge of the material in ECON-UA2. It is your responsibility to review that material in advance of taking this course.

#### **Course Description and Objectives**

This course analyzes the impact of public policy on the allocation of resources and the distribution of income in the economy. Students completing the course will know how to use the tools of microeconomics and empirical analysis to answer these questions:

- When should the government intervene in the economy or markets?
- How might the government intervene? What policy options are available?
- What are the effects of those interventions on economic outcomes and society?
- What are the short and long-term impacts of selected policies?

The assignments and exams assess all the above learning objectives.

## Required Readings

- [Jonathan Gruber, \*Public Finance and Public Policy\*, 7th edition, 2022](#). Using another edition is at your own risk as public policies are frequently revised.
- The required book for this course, **Public Finance** by Gruber, will be delivered to you digitally. You will receive an email from "BryteWave" with the instructions for accessing the material. The **cost of the book is \$74.50**, which will be added as a "book charge" to your bursar bill. If you choose to find your course materials elsewhere, you must login [here to the student portal](#) and opt out of the program by **September 18th. If you do not opt out by this date, you will be charged.**
- A microeconomics principles textbook. The course outline below refers to chapters in N. Gregory Mankiw's *Principles of Microeconomics*, but you can use any introductory text, such as the one you used in ECON-UA2. I am providing an electronic version of the Mankiw text on Brightspace.
- Several required articles and book chapters may be posted on NYU Brightspace. In most weeks, specific readings for discussion will be assigned along with a set of discussion questions. You should apply economic reasoning to the issues raised in these readings and jot down your answers to the associated questions before coming to lecture. Your answers to these questions will form the basis of some in-class discussion. ## Assignments

An assignment will be posted on the NYU Brightspace site after most lectures (see outline below). Completed assignments need to be submitted electronically, as a **PDF file attachment**. Specific directions on how and where to submit the assignments will be provided on the course website.

The weekly assignments are intended to provide timely feedback on your progress. Answer keys are posted after they are due. In general, late assignments will be assigned a 10% penalty for every day the assignment is late. **But in the case of the weekly homework assignments, late submission will not be allowed.** If you need to submit an assignment late, then you will have to use that assignment as your one dropped assignment.

Please make sure to show your work when submitting assignments. Simply providing a numerical answer without documentation of computations is not sufficient, ***therefore it would only be considered for partial credit.***

## Recitations

- Recitation problems will be posted on the NYU Classes site several days before class.
- Recitations reinforce the current week's material primarily by going over these problems. You should try them on your own before attending recitation. While attendance is not mandatory, you will need to master the content of these recitations to successfully pass the exams and complete the course; the typical student will need to attend. Recitations may also review completed assignments or address other content questions, as needed.
- Recitations complement the weekly lectures. While lectures focus on economic concepts and theories, the recitations address some of the more technical aspects of economics. Since exams consist of both theoretical/conceptual and more technical questions, a student's learning experience is optimized by actively participating both in lectures and recitations.

## Grades

Grades will be calculated according to the distribution below. There will be no makeup exams or extra credit.

- **Attendance & Participation (15%):** You must be present in class to contribute and receive credit for participation. Participation consists of two components: in-class participation and the presentation of an "economic highlight" relevant to the course content.
  - **In-class participation (5%):** If you attend regularly and contribute meaningfully to class discussions, participation will be incorporated into your final grade. You can only contribute in a meaningful way if you have completed all assigned readings and discussion questions before lecture.
  - **Economic Highlight Presentation (5%):** You will choose a topic and deliver a presentation not exceeding two minutes in length, accompanied by one PowerPoint slide. The presentation needs to be recorded and submitted on our course website [either as a combined file or two separate files]. Zoom also works well for this purpose.
  - **Response to other student's Economic Highlight Presentation (5%):** You will review the presentations submitted by other students on our course website and respond to one presentation. The response can be in the form of a written comment or audio file. Please be specific and offer some relevant constructive comments that could add to a discussion.
- **Assignments (25%):** You will receive credit for up to 10 of the 11 assignments. If you submit all 11 assignments, your worst performance will be ignored.
- **Midterm exam (30%):** The midterm will cover material from weeks 1-5 (tentative).
- **Final exam (30%):** The final exam will focus on material from weeks 7-14 (tentative), however, you will need to apply concepts learned in earlier weeks.

## Policy on Use of AI Tools

The following guiding principles are useful in assessing your interaction with AI tools:

1. The policies of Wagner require that you complete and submit **your own work**. ChatGPT and related tools can be used in ways that reduce what you learn to nearly nothing. Ethical uses of these tools are possible, but they are course-specific, and [require acknowledgement](#). As a reminder, please review Wagner's Academic Integrity Policy, which is also mentioned here on the syllabus.
2. Ethical use of generative AI tools may be utilized in this course provided that all instances of AI assistance are clearly noted alongside your work. Examples for AI use are tasks such as background research, ideation, and text editing or proofreading, but not to draft it.
3. Again, usage of ChatGPT, Bard, and other generative AI tools in your work **MUST BE ACKNOWLEDGED AS SUCH**.
4. The [shared norms of NYU](#), and of academic communities generally, requires that you do your own work. If you use these tools in your work, you need to cite them. If you don't, you are violating those norms.
5. As you're considering your use of AI, please consider the Wagner's Academic Integrity Policy.
